Mr. Wieseler provide a report to the board on no head lice since last school board meeting. The Doland School District is in the third year of the new teacher-mentoring program through the SD Department of Education. We have been using the district-run option (pair new teachers with experienced teachers in our own district.) This has be great benefit to our teaching staff. The following is a review of the calendar: January 18 no school-NCSPED in-service in Warner, January 21 no school-Martin Luther King Jr. Day(Monday), January 24-Spink County Emergency Management 911 presentation-elementary students, January 25-GBB/BBB with Britton/Helca starting at 4:00 p.m. in Doland, January 25-Sixth grade pie social, February 4-No School-Monday, and February 21-Opioid presentation from Spink County Coalition to grades 6-12.

Mr.Hulscher gave a preview of the new website to the Board of Education. Complete Media has be working on the website. A list people who have contact the school wanting to be on the vendor list, does a letter need to go to the paper and parent with information of the architects, plans to have an auction, plan to have tours, school open for tours now, hope to have a better time line within a month. The honor roll had been sent out to the local newspapers. Miss Pommer is teacher Alegbra 1 to Hillside student and Doland student via the DDN network. Senior privileges have been handed out to all seniors. A reminder was given about the junior high retention policy —must pass 7 out of 10 core semester classes. A possible CDL driver will be needed for the north bus route next year. The north bus route are currently switched in the afternoon, a new bus route letter was sent home with report cards in December. All six of the

students are going on the senior trip. The Mitchell (MTI and DWU) post-secondary trip determined when the building timeline are reviewed. The same will be for the grade 7-12 field trip will be determined when the building timeline are reviewed. Danielle H., Emily F., and Natasha A., have been selected to be legislative pages. Three student would like their legislative page duties to be considered "exempt". Graduation time survey has been sent to the parents. SDHSSA said no to six man football for the next two years. The yearbook is digital. Mr. Hulscher gave a tentative design and construction schedule along with a building demolition tentative schedule. Mr. Hulscher has spoken with the architect about the timeline.

The current enrollment for the Doland School District is 159 for grades K-12 at all the attendance centers. The Doland Center is at 98 with no preschool included, Clark Colony is 14, Hillside Colony is 22, Hillside High School is 11, and Camrose Colony is 10. The projected enrollment for the district in the fall of 2019 is at 146 students. These projected enrollments do not included preschool students or any Hillside High School students. Hillside High School did graduate six students in December 2018.

The date of the annual school board election set for on April 09, 2019. The first day of petitions may be circulate is January 25, 2019.

Mrs. Lewis provided financial information for the board. Mr. Lewis showed the board the decrease in state aid payment for December 2018. The National School Lunch program has funding until March 2019, with the government shut down. The US Government funds the NSLP quarterly. The information on the current tax levies for the Doland School was presented to the board.

Action 19-160: Motion by Schneider, 2nd by Houghtaling, to add to the Doland School unpaid meal policy. There will be no charging of milk, second milks, or second meals if the account has a negative balance for three weeks. All ayes.
